AOB

Nicola welcomed carers and professionals to the meeting, doing necessary introductions and covering housekeeping.

Housing Adaptions Review

Katy McBride introduced her role and briefed the attendees about the Clackmannanshire Carers Group Housing Adaption Review. Her presentation covered:

- **Background and Context**
- Assessment
- Timely provision
- Cost effectiveness of interventions
- Reviewing 'all housing' local authority / housing association / private rental / owner occupied

- Explanation of aids (portable pieces of equipment like toilet frames and adaptions, which are fixed. Adaptations can be minor like a handrail, or major like a wet room or stairlift.
- Increased demand for adaptations
- Existing provision

Waiting List, access to services, streamlining resources, increase in demand, rising costs .ASKSara

Katy opened up a conversation with the room and carers shared their experiences, made comments and asked questions, including:

- the process and provision for private housing
- Minor adaptations-most are happy with process /timing
- Handrail installation left with no explanation why one handrail was fitted and not two
 as two were necessary
- Ramp installation/stairlift explanation for refusal, could there be an appeal process?
- Follow up checks on major installations who deals with problems down the line?
- Discussion on Scottish Government guidelines on Accessibility for new-build housing.

IJB Carer Representative Update - Andy Witty

Andy gave an informal update as he has just officially attended his first IJB meeting. Self-Directed Support was on the agenda, a particular area of interest to Andy. Andy is concerned that there was a lot of talk about "overspend" rather than recognition that the problem is underbudgeting. Andy recognises that it is early days in his new role, and is keen to hear from carers who would like him to raise issues with the IJB.

Carers Centre Update

Nicola and Elizabeth updated attendees regarding the lack of progress on re-commissioning of carer support services across Clackmannanshire and Stirling.

Nicola provided information about the new volunteer driver scheme operating in Clackmannanshire, and the new bus service for people travelling to the Eye Clinic at Falkirk Community Hospital.



Eye Clinic Bus Service

The bus service will offer a telephone pickup service between 8.30am and 5.30pm once a week.

Patients within postcode areas FK10 to FK14 are eligible and will be required to show drivers their NHS Forth Valley appointment letter before boarding the bus.

They will then be returned to their home address, although there may be a small waiting period for the bus to return to FCH. If the trial is successful, the service will be continued and possibly expanded to include other days in 2026.

Patients are asked to book their seat by calling Order of Malta dial a journey on 01786 465355 and selecting Option 1. The bus service will be subsidised with each single trip costing £2 per passenger.

Carer Issues / AOB
